This joint venture strategically positions project professionals at the forefront of this transformation," stated Pierre Le Manh, PMP, President & CEO of PMI. "By integrating GPM's recognized certifications, learning programs, and standards into a joint venture fully aligned with PMI's global organization, we are significantly enhancing our capacity to empower our community to translate sustainability intentions into tangible, measurable outcomes. Leveraging PMI's extensive ecosystem of professionals, corporate



partners, academic institutions, training organizations, and governments, our objective is to make sustainability practical at the project level, equipping professionals and organizations globally to lead their own sustainability journeys toward a more resilient and prosperous future."

Through this joint venture, PMI will incorporate GPM's sustainability-focused certifications, frameworks, and tools, notably the GPM® P5 Standard for Sustainability in Project Management and the Sustainability Competence Standard, into its comprehensive learning ecosystem and global community platforms. These resources offer clear, actionable pathways for professionals to effectively assess, measure, and continuously improve the sustainability performance of their projects.
